Kirk Skorpanich provided an overview of the recent F&A Committee meeting. The F&A Committee met to review progress on SIATech's Strategic Planning Dashboard and key performance indicators (KPIs). Staff shared that Cabinet and Board Director Elyse Burden met with Hanover Research on August 27 to refine SMART goals for our Strategic Plan and explore best practices for data literacy, indicator alignment, and dashboard development.

Staffing updates were also provided, with SIATech currently maintaining 88 total positions across Central Office, Independent Study, and Job Corps programs. Additionally, fiscal staff and ICON presented a fiscal audit update for FY 2024–2025.
